VOCAL LESSONS AGREEMENT FORM 2025

Qualified voice teacher offers lessons at the school. The intention of providing this service to students is to complement the work of classroom teachers and support the vocal ensembles in the school. **Students must be enrolled in Vox Nova, Lyric Voices or Chorale to access vocal lessons at Kenmore State High School.**

Payment of Fees

1. Students are taught in small groups at a cost of \$15 per lesson (3-4 students), shared lesson \$22 (2 students), private lessons cost \$42 per lesson, to be paid as a lump sum at the beginning of each term.
2. **Minimum notice of 24 hours is required if the lesson will not be attended or the full fee will apply. Do not leave a message at school. Contact the teacher directly.**
3. Lessons will only be made up if the teacher is absent.
4. Term fees vary according to the number of weeks in a term, to a maximum of 11 weeks.
5. Accounts are issued on the first week of term. Payment is due by week 3. **Lessons will not continue until fees are paid.**
